- 5. MOSQUITO ABATEMENT UPDATE. With the recent heavy rains, public works has shifted into high gear. Over 1,000 thirty day larvae tablets were installed in catch basins on August 30th, and an adult spraying occurred on August 31st. Adult sprayings are also scheduled for September 14th and September 28th.

This study is required to be submitted as part of an application for up to \$25,000 in street sign replacements from IDOT. A similar project was completed in Elwood last Spring. Staff recommends approval if we intend to submit for this grant which is the next item on the agenda.

The street inventory mentioned above is part of the application and Will County is also participating. Public Works will install the new signage and retain the old signage as spares. Staff recommends approval of the application.
- 6. REQUEST FOR CLOSED SESSION TO DISCUSS PERSONNEL: HIRING A SEASONAL WORKER FOR LEAF COLLECTION THIS FALL. The Supt. Has an individual which he wishes to hire for this purpose from October 15th through December 10th and he wishes to discuss this proposal with the Board.
