## A. FINANCE AND ADMINISTRATION COMMITTEE

**TREASURER'S REPORT:** A copy of the Treasurer's report was provided to the Board for review and the Treasurer was present to answer questions.

Trustee Cleary made a motion to approve the Treasurer's Report and the Report of Financial Activity in the prior month. Trustee Meyer seconded the motion.

Trustee Cleary made a motion to approve payment in the amount of \$644.70 from the 625 Dixie Highway Account to Homewood Disposal for removal of demolition material and \$1,650 to Mike Stanula Architects for site measuring, original design of prints and re-design for second bid letting. Trustee Wehling seconded the motion.

Administrator Barber added a bill in the amount of \$163.80 to Rich Construction from the Nantucket Cove Escrow Account, to board up a broken window in Nantucket Cove Subdivision. Trustee Cleary made a motion to approve payment of a bill to Rich Construction in the amount of \$163.80. Trustee Kypuros seconded the motion.
