## REPORTS OF VILLAGE COMMISSIONS

There was nothing to report for the Beautification or Ribbon of Hope Commissions.

# A. FINANCE AND ADMINISTRATION COMMITTEE



**TREASURER'S REPORT:** A copy of the Treasurer's report was provided to the Board for review and Treasurer Rooney was present to answer questions. Trustee Basile made a motion to approve the Treasurer's Report and the Report of Financial Activity in the prior month. Trustee Meyer seconded the motion.

Variance reports for the preceding month were provided in the packet for review.

A list of bills totaling \$98,307.21 to be paid was available for review. A summary of the list of bills was provided. Trustee Basile made a motion to approve payment of the list of bills as presented. Trustee Meyer seconded the motion.

Trustee Kraus asked Lt. Emerson about uniforms on the bill list for EMA. Trustee Kraus will contact Denis Tatgenhorst and ask him.

The Board considered granting a special use permit for a drive-thru at 1121 Dixie Highway. After holding a public hearing, the Planning and Zoning Commission (PZC) recommended approval of the special use permit subject to two conditions: 1) Stripe the parking lot so no one parks or cues in the main entrance to the parking area of Lacey's at the southeast corner of the building; and 2) provide some type of security barrier between the drive-thru exit lane and the doorway located at the northwest corner of the building. The barrier will be some type of fence such as that used at McDonalds at their drive-thru. There was no testimony provided at the meeting.

ORDINANCE #1279 – An Ordinance granting a special use permit for a drive-thru at 1121 Dixie Highway. Trustee Mazurek made a motion to approve Ordinance #1279. Trustee Kypuros seconded the motion.

ORDINANCE #1280 – An Ordinance extending a balloon loan in the amount of \$350,000 to First Community Bank and Trust for a period of one year at an interest rate of 1.85%. The current loan

is due February 3<sup>rd</sup> and cannot be paid off with current debt service funds, since we haven't received the loan offer from the Illinois Environmental Protection Agency (IEPA) and we cannot draw down on \$620,000 in reimbursement funds for the design and permitting of the new sewer plant. Trustee Basile made a motion to approve Ordinance #1280. Trustee Mazurek seconded the motion.

<u>ORDINANCE #1281</u> – An Ordinance amending the IEPA loan request to reference a 30-year repayment period in lieu of a 20-year repayment period. Trustee Basile made a motion to approve Ordinance #1281. Trustee Meyer seconded the motion.
