At the hearing, a full presentation will be made by Mike Hoffman and Pete Iouse of Teska Consultants followed by Q and A and the taking of public comments. Written comments will also be taken into the record.

- VI. WORKSHOP: CONSIDER AN AMENDMENT TO BEECHER ZONING ORDINANCE PERTAINING TO THE SALE, DISTRIBUTION, TRANSPORTATION AND CULTIVATION OF RECREATIONAL CANNABIS. The Village Board has referred the issue of recreational cannabis to the PZC to come up with the proper way to zone and regulate such establishments if one is proposed for Beecher. Municipalities have been given until January 1, 2020 to either prohibit, regulate or ignore the sale of cannabis. To ignore the issue means the community is unregulated pertaining to sales. The Village CANNOT prohibit the possession or use of cannabis; this is a right granted under state law. The only regulation we can enforce is the sale of the product; similar to liquor laws.

Enclosed is a draft zoning ordinance amendment first drafted by the Illinois Municipal League and then tweaked by the Village Attorney to fit our current ordinance. We treat these types of uses as special uses, similar to a beer garden where the Village can place additional stipulations on the permit to fit the needs of the specific site. The Village Board has also invited the PZC to attend its meeting on Monday, September 26<sup>th</sup> to hear form the attorney on this issue and discuss some direction. Maps have also been provided which show the boundaries or limits of the sale areas as proposed and more information is also provided for discussion.

VII. CONSIDER A MOTION HOLDING A PUBLIC HEARING ON AN AMENDMENT TO THE ZONING ORDINANCE PERTAINING TO RECREATIONAL CANNABIS. We can choose the date or wait until next month if we need more time to discuss the ordinance.
