No permit shall be granted unless the following conditions are met:

- 1) The non-highway vehicle (golf cart or recreational off-highway vehicle) must pass an inspection for all required equipment.
- 2) The applicant must provide evidence of insurance in compliance with the provisions of the Illinois Compiled Statutes regarding minimum liability insurance.
- 3) Applicants must possess a valid driver's license.

The applicant has received and read a copy of the Beecher Village ordinance concerning the registration and operation of Non-Highway Vehicles and understands that the Village may suspend or revoke a permit granted hereunder upon a finding that the holder thereof has violated any provisions of the Beecher Village Ordinance governing non-Highway Vehicles, or there is evidence that the permittee cannot safely operate a qualified vehicle on the designated roadways. Failure to abide by this ordinance shall result in a fine of \$100.00 for the first offense and \$250.00 for subsequent offenses as outlined in Section D of 9-8-10.

Any person operating the non-highway vehicle is subject to all laws of the Illinois Vehicle Code including Driving under the Influence of Alcohol or Drugs. The capacity of the vehicle cannot be exceeded, and operators are required to comply with the Child Passenger Safety Laws. Appropriate seatbelts and safety seats are required to transport children.

By signing this application, the applicant hereby releases the Village of Beecher, its elected officials and its employees and agrees to indemnify and hold them harmless from any and all claims resulting from the operation of this non-highway vehicle on public streets.

Beecher Non-Highway Vehicle

Quick reference sheet

- All non-highway vehicles subject to registration except ATV's and off-highway motorcycles. Non-highway vehicles 64" width and 2000 pounds or less.
- Can only travel on Village of Beecher roads where the speed limit is 30 mph or less. CANNOT DRIVE ON DIXIE HIGHWAY OR INDIANA AVENUE or any other county road.
- Can cross Dixie Highway at a stop intersection where the speed limit on Dixie is 40 mph, Chestnut Street and Church Road.
- Can cross Indiana Avenue at intersections.
- Equipment required: Brakes, a steering apparatus, tires a rearview mirror, red reflectors in the front and rear, a slow moving emblem on the rear, a headlight, a tail light, brake lights and turn signals.
- Lights must be illuminated when driven on the roadway.
- Must have insurance on the non-highway vehicle.
- Must have a valid driver's license to operate the vehicle.
- May operate on sidewalks but cannot use crosswalks to cross Dixie Highway or Indiana Avenue. Care must be taken when operating on sidewalks; pedestrians have the right of way.
- Can only transport the allowable number of persons for the non-highway vehicle.
- Must have seat belts for anyone less than 18 years of age.
- Annual registration begins June 1st of each year at the cost of \$25.00.
