A motion is needed to open and close the public hearing. It is staff's understanding that the petitioner of record has withdrawn the application since his legal interest in the property has expired. Enclosed is a the exploratory approval, special use approval, and preliminary plan approval, along with the engineering for the one lot final plat of subdivision. Any approvals have to be contingent on Baxter and Woodman review and approval, AND a commitment from the developer that the covenants as approved by the PZC in 2021 be recorded with the final plat.
